In accordance with 1 V.I.C. § 171, whenever any holiday (other than Sunday) falls upon a Sunday, the Governor by Proclamation may, in his discretion, grant administrative leave on the following Monday or decide whether they will be recognized with a week-day observance or not. Other exceptions are Organic Act Day (Third Monday in June), Supplication Day (Fourth Monday in July) and Local Thanksgiving Day (Third Monday in October).
